## MINUTES OF THE AUGUST 21, 2018 REGULAR MEETING OF THE BOARD OF COMMISSIONERS OF KING COUNTY FIRE DISTRICT NO. 2

A regular meeting of the Board of Commissioners of King County Fire District No. 2 was held at Headquarters Station 28 on August 21, 2018, commencing at 5:00 p.m., pursuant to proper notice. District officials in attendance were: Commissioners Elwell and Sitterley, Chief Mike Marrs and District Secretary Joseph Quinn. Others in attendance are as shown on the Attendance Roster, attached. Commissioner Peden was excused.

**Call to Order.** The meeting was called to order at 5:00 p.m. by Commissioner Elwell who led the Pledge of Allegiance to our flag. A motion was passed unanimously to excuse Commissioner Peden from attendance at this meeting.

Personnel. Chief Marrs updated the board on the DRS dispute. By letter dated August 16, 2018 the DRS Petitions Examiner denied our petition for lack of standing. However, the letter says that employees or former employees can petition. The Chief and Attorney Dave Luxenberg disagree with this denial. The meeting with DRS personnel went well in that pensioners were allowed to delay any payback of pension amounts received. The board and Chief questioned the propriety of this DRS action.

September 27<sup>th</sup> is the date of the written part of the Captains test, Chief Marrs said. This just covers King 2 personnel, not North Highline Fire personnel.

The Chief said Joe Kupferling is back from California. The department has been involved with wildfire fighting along State Route 18 here in King County, which included helicopter water drops. Joe is getting good experience. He ran a strike team including five engines at the California Fire known as the Mendocino complex.

The Chief said Christina Parker's one year probation period ended August 14th and there is a motion for permanent appointment on tonight's agenda.

<u>Events.</u> Chief Marrs said there is a Retreat on Thursday for the North Highline commissioners. A preliminary version of the North Highline agreement will be coming. Commissioner Julie Hiatt of North Highline has been very helpful in contract talks between the two districts.

Consent Agenda. The Consent Agenda, all of which was approved 2-0, upon a motion made by Commissioner Sitterley and seconded by Commissioner Elwell, consisted of the Chief's Report and vouchers as follows: <a href="Expense Fund: No.E18-457">Expense Fund: No.E18-457</a> through No. E18-521, in the amount of \$797,764.43 due for payment August 31, 2018.

New Business. 1. Motion: Christina Parker – Permanent Assignment Commissioner Sitterley moved, and Commissioner Elwell seconded, a motion to assign Christina Parker to a permanent Administrative position upon her completion of the one-year probation period, effective August 1, 2018. Chief Marrs added that she is doing a great job and is a wonderful addition to the staff.

Chief Marrs mentioned that Burien Fire and all other fire districts and Regional Fire Authorities in King County received a letter from King County proposing to consider contracts for services provided to King County's properties served by fire departments (historically for free) pursuant to the mandate of RCW 52.30.020. He said that Attorneys Quinn and Snure (and maybe more) are dealing with it to present a unified front among the fire departments in King County, so stay tuned for further developments.
